## Who can vote?

- a) All Portuguese citizens;
- b) **European Union** nationals;
- c) **United Kingdom** nationals with residence in Portugal **prior to Brexit**;
- d) Citizens of **Brazil and Cape Verde** with a valid residence permit in Portugal for over two years;
- e) Citizens of **Argentina, Chile, Colombia, Iceland, Norway, New Zealand, Peru, Uruguay and Venezuela** with a valid residence permit in Portugal for over three years.

## Which documents are necessary in order to register to vote?

- a) Valid residency title – Registration Certificate for an EU Citizen (CRCUE), Residence Card (CR), Residence Permit (AR) –, if you are an **European Union national, or an United Kingdom national with residence in Portugal prior to Brexit**;
- b) Proof of minimal time of residence in Portugal:
  - over two years, if you are a national of **Cape Verde or Brazil**;
  - over three years, if you are a national of **Argentina, Chile, Colombia, Iceland, Norway, New Zealand, Peru, Uruguay and Venezuela or of the United Kingdom, after Brexit**;
- c) Official Declaration specifying:
  - your nationality and address in national territory,
  - if applicable, the electoral roll of the circle or local municipality of the State of origin where you were last registered.

In the case of nationals outside of the EU, this Declaration should also include:

- that your right to vote in the State of origin has not been revoked.



# When can I register to vote?

As soon as possible, **before the 60<sup>th</sup> day before Election Day.**

# Who can be elected?

- a) Portuguese citizens;
- b) European Union nationals;
- c) United Kingdom nationals with residence in Portugal prior to Brexit;
- d) Citizens of **Brazil and Cape Verde** with a valid residence permit in Portugal for over four years.
